Overview

TACCHO's *Education through Innovation Award* recognizes the educational efforts by local health departments in Texas who:

- ✓ Create, disseminate, and promote public health initiatives, education, or messaging
- ✓ Demonstrate originality with measurable positive impacts on a target audience.

Innovation Criteria:

Originality • Measurable Impact • Efficiency • Replication • Cost-Effectiveness • Relevancy • Feasibility

Award Instructions and Information

- ✓ Complete the nomination form and logic model by typing/printing legibly.
- ✓ Include relevant supporting materials: slide decks, promotional materials, links to web pages, examples of social media/electronic dissemination of information, pertinent data that supports the positive impact of the target audience engagement.
- ✓ Include as much about the work as possible. Remember, the initiative and the resulting impact might not be obvious to the selection committee.
- ✓ Nominees must be active (dues-paying) TACCHO members who are in good standing with TACCHO
- ✓ Selection will be based solely on the information contained in the nomination.
 - Make sure you complete and submit all parts of the award nomination form.

Submission Deadline: February 15, 2026

Evaluation

Nomination review and scoring is performed by the ELT Awards Committee, which consists of ELT members, the Executive Director, and Local Health Department staff members. Scoring Criteria are based upon the quality of the application and achievement(s) described.
